4. FIRST AID MEASURES.

General

In all cases of doubt, or when symptoms persist, seek medical attention.
Never give anything by mouth to an unconscious person.

Inhalation

Remove to fresh air, keep the patient warm and at rest. If breathing is irregular or stopped, administer artificial respiration. Give nothing by mouth. If unconscious, place in the recovery position and seek medical advice.

Eye Contact

Contact lenses should be removed. Irrigate copiously with clean, fresh water for at least 10 minutes, holding the eyelids apart, and seek medical advice.

Skin Contact

Remove contaminated clothing. Wash skin thoroughly with soap and water or use a proprietary skin cleaner. Do NOT use solvents or thinners.

Ingestion

If accidentally swallowed obtain immediate medical attention. Keep at rest. Do NOT induce vomiting.

5. FIRE FIGHTING MEASURES.

EXTINGUISHING MEDIA

Recommended: Alcohol Resistant Foam, Carbon Dioxide, Powder, Water Spray/ Mist.
Not to be used: Water jet.

RECOMMENDATIONS

Fire will produce dense black smoke containing hazardous products of combustion (See Section 10). Exposure to decomposition products may be a hazard to health. Appropriate self-contained breathing apparatus may be required. Cool closed containers exposed to fire with water spray. Do not allow run-off from fire fighting to enter drains or water courses.

6. ACCIDENTAL RELEASE MEASURES.

Exclude sources of ignition and ventilate the area. Exclude non-essential personnel. Avoid breathing vapours. Refer to protective measures listed in Sections 7 and 8. Contain and collect spillages with non-combustible absorbent materials, e.g. sand, earth, vermiculite, diatomaceous earth and place in a suitable container for disposal in accordance with the waste regulations (See Section 13). Do not allow to enter drains or water courses. Clean preferably with a detergent; avoid the use of solvents. If the product enters drains or sewers, the local water company should be contacted immediately; in the case of contamination of streams, rivers or lakes, the National Rivers Authority.

7. HANDLING AND STORAGE.

HANDLING

Vapours are heavier than air and may spread along floors. They may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations in air and avoid vapour concentrations higher than the Occupational Exposure Limits.

Additionally, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard. Keep the container tightly closed. Exclude sources of heat, sparks and open flame. Non-sparking tools should be used.

Avoid skin and eye contact. Avoid inhalation of vapour and spray mist.

Smoking, eating and drinking should be prohibited in areas of storage and use.

For Personal Protection, see Section 8.

Never use pressure to empty: the container is not a pressure vessel.

Always keep in containers made of the same material as the supply container.

Good housekeeping standards and regular removal of waste materials will minimise the risks of spontaneous combustion and other fire hazards.

STORAGE

Observe the label precautions. Store between 5°C and 25°C in a dry, well ventilated place away from sources of heat, ignition and direct sunlight. No smoking. Prevent unauthorised access. Containers which are opened should be properly re-sealed and kept upright to prevent leakage.

Store separately from oxidising agents and strongly alkaline and strongly acid materials.

8. EXPOSURE CONTROLS/ PERSONAL PROTECTION.

ENGINEERING MEASURES.

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and general good extraction. If these are not sufficient to maintain concentrations of particulates and/or solvent vapours below the relevant occupational exposure limits, suitable respiratory protective equipment should be worn (See Protective Protection below).

PERSONAL PROTECTION

All PPE, including RPE, used to control exposure to hazardous substances must be selected to meet the requirements of the COSHH Regulations.

RESPIRATORY PROTECTION.

Air-fed respiratory protective equipment should be worn when this product is sprayed if the exposure of the sprayer or other people nearby cannot be controlled to below the occupational exposure limit and engineering controls and methods cannot reasonably be improved.

HAND PROTECTION

When skin exposure may occur, advice should be sought from glove suppliers on appropriate types. Barrier creams may help to protect exposed areas of skin but are not substitutes for full physical protection. They should not be applied once exposure has occurred.

EYE PROTECTION

Eye protection designed to protect against liquid splashes should be worn.

SKIN PROTECTION

Cotton or cotton/ synthetic coveralls are normally suitable. Grossly contaminated clothing should be removed and the skin washed with soap and water or a proprietary skin cleaner.

10. STABILITY AND REACTIVITY

Stable under the recommended storage and handling conditions (See Section 7).

In a fire, hazardous decomposition products such as smoke, carbon monoxide, carbon dioxide and oxides of nitrogen may be produced.

Keep away from oxidising agents and strongly alkaline and strongly acidic materials to prevent the possibility of exothermic reaction.

11. TOXICOLOGICAL INFORMATION

COSHH requires that persons exposed to products containing Hexamethylene -1,6 - di isocyanate which is a respiratory sensitiser, are subject to health surveillance. Publications giving guidance on health surveillance are listed in Section 16. Employees should be provided with a copy of the HSE pocket card containing information in isocyanate 2 pack spray paint.

Exposure to organic solvent vapours may result in adverse health effects such as irritation of the mucous membrane and the respiratory system and adverse effects on the renal and central nervous systems. Symptoms include headache, dizziness, fatigue, muscular weakness, drowsiness and in extreme cases, loss of consciousness. Repeated or prolonged contact with the product may lead to removal of natural fats from the skin resulting in non-allergic contact dermatitis and absorption through the skin. Splashes in the eyes may cause irritation and reversible local damage.

Ingestion may result in the following effects: sore throat, abdominal pain, drowsiness, nausea, vomiting and diarrhoea. Other effects may be described for exposure to vapours.
